The following refund of fee guidelines are brought to the notice of the prospective students:

1. The student is required to submit all the original certificates and the requisite course fee to the University for the confirmation of admission at the time of counseling.

In the event the candidate desires to retrieve his / her original certificates for the purpose of appearing for counseling session at other centers, he / she may do so by giving in writing a request for return of certificates. He / she will have to, however, surrender all the original certificates before the commencement of the classes, scheduled on **Aug 2nd , 2010**.

2. The student who has been allotted an admission to the course based on the rank list notified by the university will be given time to join the institution on or before **July 31, 2010**, as notified in the calendar of events.
3. If the student desires to forfeit the seat allotted to him before the last date of joining the institution, i.e. **July 31, 2010**, the fees after deduction of **Rs.10,000/-** towards processing fees will be refunded to him along with the other original certificates if any surrendered by him to the University.
4. If the student desires to forfeit his / her seat after the date of commencement of classes i.e. **Aug 2nd 2010 and on or before 16th August 2010**, he / she will be refunded the fees after deducting **10%** of the tuition fee paid by the student.
5. If the student forfeit's his / her seat after **16th August 2010** and on or before **25.09.2010**, he will have to forfeit, the course fees for first year paid by him. However, the certificates if any surrendered by him would be returned.
6. Any forfeiture of seats after **26.09.2010**, would involve the student having to pay the full course fee of four and half years, as the consequent vacancy created by such forfeiture cannot be filled by the University.

The above guidelines are final and no request to vary from the above guidelines will be entertained.
